Upon earning an [Associate of Applied Science in Physical Therapist Assistant](#), graduates are prepared to take the National Physical Therapist Assistant Examination (NPTAE) provided by [The Federation of State Boards of Physical Therapy](#) and must receive a passing score in order to become a licensed PTA in Montana. Licensure is required to practice as a PTA in Montana and is overseen by the State of Montana Board of Physical Therapy Examiners.
